 - Collaboration with other IPC leads essential




IPC Student Support Experience - Tips

 - Name badge identify the role, Photo in facility who is who







Establishing the IPC Lead Role in the Facility: Tips and Tricks

• Establish:

- Organisation guide on how to establish the IPC lead role
- A role description- based on facility needs and IPC lead ability/capacity
- Communication pathway- how IPC issues get to the IPC lead
- An IPC lead folder index of IPC evidence
- Role orientation introduce role to the team, residents/families, GPs etc
- Meeting agenda -Permanent IPC section staff, resident and families, MAC etc





Establishing the Infection Control Lead Role (ICL)

Introduction

There are 7 parts to establishing and setting up the Infection Control Lead (ICL) role:

- Quality Standard requirement
- Choosing the right person for the role
- Education requirements
- Submission to aged Care Portal and consent
- Role requirements, task list and
- Ongoing education and support
- Evidence of role actions

1. Infection Control Leads a Quality Standard requirement in all residential care homes

- Standard 3, specifically Requirement (3)(g) regarding minimisation of infection control risks
- Standard 7, specifically Requirement (3)
 (c) regarding the workforce competency and holding relevant qualifications and knowledge
- Standard 8, specifically Requirement (3)(c) regarding effective workforce governance systems.

2. Qualities of the ICL

Qualities for considerations in the ICL role:

- Works currently at the single site and over at least 4 days (night duty does not work- less days does not provide the ongoing IC cover)
- RN/EN (very difficult for EN)
- Able to complete a fevel 8 course this is at Master's level
- Can meet the Arcare ICL Duties



Infection Control Lead Duties

The following tasks fall within this position's responsibilities:

Daily	
0	Is a dedicated ICL to the residence
	Act as a resource and mentor to all staff on issues related to infection prevention and control at floor level
	Is the residence key infection control contact
	Have knowledge of Aged Care Quality Standard 3 (3)(g) and 8 (3) (d) (e) and applying
	Visit all areas of residence to oversee that standard infection prevention and control practices are being carried out in accordance with written Arcare and State/Australian Guidelines.
	Initiate and maintain communication with staff and shares information, elicit feedback, and encourage participation in Infection control precautions
	Feed's infection control concerns to Residence Manager (RM) and National Infection Control Specialist (NICS)
Specia	lized tasks
0	Provides support regarding the assessment, planning implementation, documentation, and evaluation of transmission precautions of infectious clients, carriers of multi-resistant organisms or those in quarantine
	Attend/assists with delegated infection control related audits (i.e., national audit schedule – i.e., cleaning, waste, infection control) and monthly residence infection stats
	Assists with rolling out action plan/change processes in accordance to audit outcomes as delegated by Clinical lead) CL/RM
	Assists CL/RM with outbreak preparation (including outbreak supply), management, and reflective reviews.



Infection Control Lead Communication Framework

Feedback on the identification of infection control issues should be welcomed by everyone. A process to escalate this, review and action is required. The following framework will provide a suggestion to do this, however there will be other ways and individual facility needs must be factored.

- Awareness to whom is the Infection Prevention and Control Lead (IPCL) is required across the facility – this includes all team members, residents/representatives. Information on the role, who it is and contact information (email/phone) can be addressed in meetings, written communications and 'staff who is who' wall photos.
- Where infection control issues are identified, they are escalated to the IPCL via phone, in person or email.
- Issues are then listed in a facility Infection, prevention and control action plan. An example of an action plan is below and enables a process for review, action, follow up and sign off.
- Ongoing monthly or second monthly IPCL meeting are held with the Facility Manager to ensure progression of the action plan, oversite and assistance.
- The running action plan will provide evidence of practice change and continuous improvement in infection prevention and control
- The action plan also demonstrates the activities and actions undertaken by the IPCL and can assist with determining needed time in the IPCL role

- ICL education attendance register: Monthly National Infection Control education sessions (varied topics) and monthly ICL workshop attendance.
- 5. **Minutes:** (IPC associated meetings, ICL and RM meetings, MAC participation etc)
- IPC scheduled training onsite by ICL: to mirror National Infection Control education schedule and any other training required

- Accreditation evidence
- Change process:
 - Identification, action, outcome
 - Follow up and closure
- Safer environment
